

River Run ATV Park Pet Waiver

I am aware that during the course of my visit to River Run ATV Park certain inherent risks are involved because I am attending with my dog. In consideration for being allowed to come to River Run ATV Park with my dog I agree to assume FULL AND TOTAL liability for any and all damages and expenses including, but not limited to, injury to a person, property, other pet or wildlife that are alleged to have been caused in total, or in part, by the direct or indirect activities of my pet, me, and/or other persons coming to River Run ATV Park with my dog. I agree to hold harmless and indemnify from any cause of action, that directly or indirectly involves my dog, River Run ATV Park, all corporate officers, agents, employees, guests, and other individuals acting in an official or advisory capacity. I further agree to hold harmless and indemnify from any cause of action that directly or indirectly involves my dog, Cherokee County, including all individuals and agents acting in an official or advisory capacity. I agree to pay for the costs of attorney fees and court costs incurred by the above-mentioned parties to defend any actions, in addition to any other costs and damages that may be assessed

If my dog should bite a person, bite another pet, cause property damage, and/or be directly or indirectly involved in any incident I agree to the following:

1. Report the incident immediately to a River Run ATV Park management or staff member; and,
2. Keep my dog available until I have received instructions from the River Run ATV Park staff and/or local authorities regarding the required procedures.

I certify to the following facts:

1. I will **always** be in control of my dog during my visit
2. That my pet has never been involved in a dog/person or dog/dog incident
3. That my dog has not been deemed dangerous or potentially dangerous at any time in the past.
4. I certify that all information contained in this form is accurate.
5. My dog has never caused a problem in public places like resorts, recreational parks, dog parks, etc.
6. I will carry adequate liability insurance coverage while at River Run ATV Park.
